Though it is a contest, it is also a chance to make friends and memories for a lifetime. But that is all up to you.

Attached are several forms which we need you to complete in order for you to become a contestant. The deadline for the receipt of this information is March 31, 2023. **THIS IS A HARD DEADLINE**. In order for you to compete in one of the contests, it is critical that these forms be received by the Producer, Michael Hobbs, no later than the deadline date. This information is used by both the Administrative Staff and the Judges, and may be released to the general public as part of an announcement of the contestants.

We will be scheduling a contestant meeting, probably on April 2, 2023. We will be discussing the schedule, expectations, and each portion of the contests. Where this meeting is not mandatory, it will greatly benefit you to attend this meeting.

By submitting an application, contestants agree to submit to a possible drug test prior to the contest and again at random intervals during the title year should you win. You may forward any and all questions to Michael Hobbs at 720-771-4615 or Producer@LeatherColorado.org.

Once your application is received, **Leather Colorado Foundation** staff will send a confirmation advising you when to check-in with the contest officials along with other detailed information. You will also be sent a copy of the Titleholder Agreement for your review.

Rules and Regulations

Congratulations and welcome to the **Leather Colorado Foundation** family! We hope you are excited about competing, and we're glad you'll be part of the **Leather Colorado Foundation's Family of Contests**. Once you have read this information carefully and you have provided all of the information requested, deliver or mail the application to the **Leather Colorado Foundation** at the address shown below.

1. **Mr Leather Colorado™, Mr Colorado Rubber™, Colorado Bootblack™, Ms Leather Colorado™, Miss Leather Colorado™, and Colorado Master/slave™** Contestants *may* be the winner of a bar or local leather contest (a "preliminary contest") past or present; **OR** be sponsored by a bar, business, club, or organization that specializes in the levi/leather, uniform, S/M, western, or related lifestyle **OR** represent themselves independently. If representing a business or organization, each such business or organization may only sponsor one contestant for each title.
2. All contestants must be 21 years of age or older and a resident of the state of Colorado as of the day that you register for the contest. In order to verify your eligibility to compete, ***include a copy of your government issued photo identification (driver's license, state ID, or passport) with your Contestant Application packet.*** No person may compete more than 4 times for a title. No person may compete for this state title if you have held a similar regional, national, or international title within the last 10 years.
3. There are no gender requirements to compete for any title, regardless of the implication of the title name. However, the international contest that you will be expected to compete at, should you win the Colorado title, *may* have a gender expectation and/or requirement. The **Leather Colorado Foundation** will work to gain you access to that contest, but cannot guarantee the acceptance of your application.
4. Contestants must sign the Titleholder Agreement **before** April 2, 2023, and return the agreement to the Producer at the **Leather Colorado Foundation** before this date. This agreement will be the main topic of discussion at the Contestants' Meeting which is tentatively scheduled for Sunday, April 2, 2022. Attendance at the Contestants' Meeting is strongly encouraged.
5. Contestants must participate in the fund raisers that are planned by the Foundation. Many of these fundraisers are beer busts at various bars. These fundraisers and beer busts are important in starting the necessary fundraising for the **Leather Colorado Foundation** to send titleholders to their respective regional, state, and international contests. You are encouraged to bring several people with you to help pour so that we meet our minimum number of pourers.
